# Angulo Barturen, Carmelo (Spain)

President of UNICEF Spain.

Degree in Law and International Relations. Higher education in Nancy and Strasbourg (France), The Hague and Diplomatic School in Madrid. He joined the diplomatic career in 1977. He was Director General and Vice-President of the Ibero-American Cooperation Institute (ICI) and in 1988 he was the first Director General for Latin America in the new Spanish Agency for International Cooperation (AECI).

As Ambassador of Spain in Bolivia (1990), Colombia (1993), Argentina (2004) and Mexico (2007), he has accompanied the implementation of many Spanish companies and investments in Latin America. It has also accompanied the innovative role of culture and Spanish development cooperation.

In the facet of Representative of the United Nations Development Program (UNDP) and Resident Coordinator of the United Nations in Nicaragua and Argentina (1996-2004), he was in charge, from the Buenos Aires Office, of one of the cooperation programs And investment of the United Nations System, managing funds from the World Bank and the IDB. Since October 2011, for one year, he was the Executive Director of the Spain-Mexico Foundation. Coordinated, in the Office of Human Rights of the Ministry of Foreign Affairs, the "National Business Plan and Human Rights", in the period 2013-2014. He is currently Director of the Institute for Cooperation and Human Development at the Camilo José Cela University, where graduate courses and seminars, voluntary activities and seminars related to CSR and public-private ventures are organized. In January 2014 President of UNICEF was appointed Spanish Committee by the Board of Trustees of this organization, which he had been in since 2013. Since mid-2015, he advises the Office of the High Commissioner for Human Rights and the Ministry of Foreign Affairs, Of Guatemala, with a view to the implementation of a national strategy on companies and human rights. Since 2015, he has been a member of the Business Advisory Board (communication) of the Francisco Luzón Foundation for the fight against ELA.

He has been decorated by several Latin American and African countries; Regularly publishes articles in the Spanish and foreign press related to international politics, economic relations and cooperation for development.

# **Attou, Yves (France)**

Yves Attou is a founding member and the President of the World Committee for Life-long Learning (CMA), position that he has occupied for the past 12 years. Throughout his career, he has directed different organizations in the fields of continuing education and professional integration. Amongst which, he headed the European Center of the World Radio and Television Council(WRTVC). In 1999, he joined the Office of Mrs. Ségolène Royal, Minister in charge of School Education, as a technical advisor. Furthermore, Yves Attou performed at the administration services at the Prime Minister Office

(General Secretariat of Government - DSAF) until 2008.

#### Beckers, Laëtitia (Belgium)

Laëtitia Beckers is a member of the Training Committee at UEAPME. UEAPME (Union Européenne de l'Artisanat et des Petites et Moyennes Entreprises) is the employer's organisation representing the interests of European crafts, trades and SMEs at EU level. UEAPME is a recognized European Social Partner and acts on behalf of crafts and SMEs in the European Social Dialogue and in discussions with the EU institutions. UEAPME represents over 12 million enterprises with nearly 55 million employees across Europe. Laëtitia represents UEAPME in the ECVET Users' Group and the ECVET Working Group. She is also an expert in the ET2020 Adult Working Group at the European Commission. Laëtitia also has a significant experience in organizing and managing VET training for young adults (IVET) and adults (CVET) in the building sector. She works closely with trainees, trainers and companies on a daily basis. In addition, she is an active member of the Euro apprenticeship network and REFORME network as she is the European Project Leader in a Belgian training organization. Laëtitia is leading several European projects, including strategic partnership (KA2) and she is responsible for mobility placements for trainees and trainers (KA1). # **Bokova**, Irina (Bulgaria)

Irina Bokova has been the Director-General of UNESCO since 15 November 2009, and was reelected for a second term in 2013. She is the first woman and the first Eastern European to lead the Organization. Having graduated from Moscow State Institute of International Relations, Irina Bokova was a Fellow at the University of Maryland (Washington) and followed an executive program at the John F. Kennedy School of Government (Harvard University). She began her career at the United Nations Department at the Ministry of Foreign Affairs of Bulgaria. Appointed in charge of political and legal affairs at the Permanent Mission of Bulgaria to the United Nations in New York, she was a member of the Bulgarian Delegation to the UN World Conferences on Women in Copenhagen, Nairobi and Beijing. She was elected twice as Member of Parliament and she served as the Government's first Secretary of European integration. As Director-General of UNESCO, Irina Bokova is actively engaged in international efforts to advance quality education for all, gender equality, the protection of the world's cultural heritage as a humanitarian imperative and security issue to strengthen the foundations for lasting peace. She actively promotes culture as a driver for development, along with science diplomacy and cooperation. She spearheads global awareness and campaigns to counter youth radicalization and prevent violent extremism, hate speech and discrimination, starting with action through education Irina Bokova has received state distinctions from countries across the world and is Doctor honoris causa of leading universities.

#### Bouche Osochowska, Marlena R. (France)

Director of the 5th World Lifelong Learning Forum, Madrid, 2017, and International Consultant, She has been working as a Special Advisor to Governments, Project Director, researcher and international lecturer, for a number of UN agencies (UNESCO, UNDP, UNOPS, UNFPA, WHO, UNICEF, UNHCR, DHA, FAO, WFP and the WORLD BANK), for European Union, Bilateral Development Agencies and Non-Governmental International Organizations. This has included over 25 years of field interdisciplinary activities in more than fifty countries around the world, and 10 years permanently in Africa. Since the Fall of the Wall, she was dealing with social transformations and Culture of Peace in Central Europe, Central Asia and Caucasus. She is operationally active on Global Health and Education, Lifelong learning and Sustainable Development, covering projects identification and formulation, operational research, field studies, focused on child growth and development, women and girls' education, adolescents' reproductive and sexual health, HIV/AIDS prevention, Youth and gender issues, Nutrition and Rural Development. To support the UN 2030 Sustainable Development Agenda, she takes an active part in alleviation of poverty through social and behavioural changes. Author of numerous publications in French, English, Russian and Polish.

#### Caetano, Lucia (Brazil)

Lucia Caetano is a Brazilian journalist with more than 15 years of experience as a Director of Corporate Communication. Since 2009, she has been volunteering as a Director for the *Instituto Asas Comunicação Educativa*, a non-profit NGO. Besides holding a position in its Board of Director, Lucia has been responsible for developing and coordinating projects which aim to promote the knowledge of media and communication tools to broaden the participation of citizens in society and to awaken their critical thinking. Under her management, the Institute attended over 10,000 people, most of them 12 to 24 year olds. Thousands of young Brazilians had the opportunity to beheard through the projects lead by Lucia and her team. Always with focus on participatory and dialogical methodologies, she is currently working on a new project about Media to be applied to formal and non-formal education. In 2015 the project "Literary festivals: young reporters" was awarded with the prize *Brazil, for a country of readers*, given by the Ministry of Culture.

#### Chitoran, Dumitru (Romania)

Prof Dr. Dumitru Chitoran was Faculty Dean and Vice Rector of the University of Bucharest before joining UNESCO's European Centre for Higher Education (CEPES) located in Bucharest in 1983. In 1989, he was transferred to the UNESCO Secretariat in Paris, as Chief of the Higher Education Section. He had responsibilities for several UNESCO activities and initiatives related to higher education, including the preparation and launching of the UNITWIN/UNESCO Chairs Programme, the preparation of the World Conference on Higher Education (WCHE, Paris, 1998), the World Forum of UNESCO Chairs (2001), the Meeting of Higher Education Partners as a follow up to the WCHE, (Paris, 2003) etc. He served also a special advisor to the Director General of UNESCO, representing him in the Council of the University for PEACE in Costa Rica and helping set up the network of European universities committed to promoting academic cooperation with the Palestinian universities, known as the PEACE Programme.

# Da Cruz Serra, Antonio Manuel (Portugal)

Rector UNIVERSIDAD DE LISBOA. Graduated in Electrotechnical Engineering by the Faculty of Engineering of the University of Porto, he holds a doctorate in Electrical and Computer Engineering at Instituto Superior Técnico. He is Full Professor of the Department of Electrical and Computer Engineering of the IST, works in the scientific area of Electronic Instrumentation. Its scientific research activity has been carried out at the Telecommunications Institute (IT) – polo de Lisboa since 1994.

From 2006 to 2009, he was President of IMEKO, International Measurement Confederation, the leading international scientific organization in the field of Instrumentation and Measures. He is currently Chairman of the Advisory Board of this organization.

He was Rector of the Technical University of Lisbon (2012-2013), President of the Higher Technical Institute (2009 – 2012) and member of the IST Board of Directors and the Deputy Chairman of Administrative Affairs (2002-2008).

In the period 2010 – 2012 he was President of the Cluster, a network made up of some of the best European schools and universities in science and technology, which includes a total of 3,000 teachers, 11,000 researchers and about 140,000 students. Member of the evaluation panels of scientific research projects in the field of electronic instrumentation, proposed for the financing of the government agencies of the Czech Republic, "Grantová Agentura Ceské Republiky" and "Ministero dell'Università and della Ricerca Scientifica and Technology "Italian Republic. He is the author of 220 scientific publications.

#### Dramé, Alpha (Switzerland)

Alpha Dramé is a specialist of development and ecology. He worked for the OMC and the CNUCED as an expert on the questions of the impact of environmental norms on trade and development before obtaining a mandate of research at the Direction of Development and Cooperation (DDC) at the *Département Fédéral des Affaires Etrangères* (DFEA) in Switzerland. He has been employed by the State of Geneva, first as reviewer for accounts at the cantonal inspection of finances, then as a coordinator of projects at the Service of International Solidarity. In 2003, he was the "Green" municipal advisor of the city of Geneva before becoming Director at the *Institut International d'Ecologie Industrielle et d'Economie Verte*. Furthermore, he is Secretary-general at the *ASF (Apprentissages Sans Frontières)*

He co-founded the *Association de pédagogie cybernetique*, an institution that will play an important role for the development of programmed education. He is the founder of the National Association of Scientific Clubs in

France, known today as *« Planète Sciences »*, where more than 1 million youth have been initiated to the management of projects for the last 40 years. Pioneer of the *« development training »* that follows a global, functional, and integrated approach for the training action, he has performed numerous intervention for big enterprises (Elf, BNP, CEA, Air France, etc) in many different domains. In 1979, he co-created the *« Chambre syndicale des Professionnels de la formation (CSFC) »* where he occupied the position of President for 11 years. Furthermore, he presided the *«* Chambre Professionnelle des Métiers du didactique » until 2013, he has served as President of the Programme Committee of EDUCATEC, he is consultant at UNESCO, and he has coordinated the options of an Undergraduate Degree in Ethics and Human Rights at the University of Nantes. Pierre-Julien Dubost is officer at the *« Ordre de la Légion d'honneur »*, and Commander at the *« Ordre du Mérite national »* and the *« Palmes académiques»* 

# Eshetu, Gurmu (Ethiopia)

Eshetu Gurmu, BA in Sociology, MSc in Demography at the Addis Ababa University (AAU). PhD in Biological Anthropology, University College London, UK, (2005). He is an Associate Professor of Population Studies and Anthropology. Currently He is a Head of the Population and Gender Research Unit by the Institute of Development and Policy Research/AAU, with more than 20 years of teaching and research experience, covering: research methods, statistics for demographers, techniques of demographic analysis, Management of Reproductive Health Programs, Population, Health and Nutrition, Migration and Urbanization. Dr Eshetu was a Post-doc/Research Fellow at the Population Research and Training Unit of the North-West University (South Africa) in 2012, and a Visiting Professor at the Institute of Advanced Studies of Bristol University (UK) in 2013. Guy Fortier holds a Master's degree in Andragogy and a Second Cycle Certification in Public Administration. He is an acting consultant for an international network of experts as a Director of CamProf Inc, an international consultancy in skills development. For UNESCO, he was involved in the development of the Global RVA Observatory, in a recent research on RVA of basic youth and adult education and led a case study on TVET in Canada. He contributed to the implementation of the Recognition of Acquired Competencies (RAC) plan of action as part of the Québec Government Policy on Adult and Continuing Education and Training. He acted as Vice-chair of the Canadian Association of Prior Learning and Assessment (CAPLA) to intensify the impact of Recognition of Prior Learning (RPL) in Canada. 1996. In 1979, he receives the Award *Prix national de sciences Clodomiro Picado Twight*, and in 1977 the French Government will award him with the honorable title of *"Chevalier de l'Ordre des Palmes Académiques"*. Furthermore, the University of New-York will give him the title of "Doctor of Humane Letters". In 1987, he joins the *Conseil consultatif du Centre régional pour l'Enseignement Supérieur en Amérique Latine et des Caraïbes* before becoming President at the *Comité Consultatif en Génétique et Biotechnologie du Conseil International des Unions Scientifiques*.

# Mairal, Ricardo (Spain)

Vice-rector of Planification and Professor at UNED.

Ricardo Mairal is Full professor of English Language and Linguistics at the Department of Foreign Languages of the UNED since 2002. After graduating from the University of Zaragoza, he taught at the Autonomous University of Madrid for four years, where he moved to UNED. The Grammar of Paper and Reference. Introduction, advances and applications (Akal, 2012). He has published more than fifty scientific articles that have appeared in national and international journals. He has participated as a speaker in numerous theoretical and applied linguistics conferences (AESLA, AEDEAN, AELCO, International Role and Reference Grammar Conference, Functional Grammar Conference, etc.); Has lectured in Germany, Argentina, Chile, the United States, Finland, Ireland, Italy, Mexico, Beijing, Taiwan, etc. And has led and participated in more than a dozen research projects financed by public entities, where aspects have been developed on the language industry. He is co-founder of the research group LEXICOM (www.lexicom.es), which brings together a remarkable number of researchers from various national and international institutions. He is currently working on the design of a multifunctional knowledge base in a multilingual environment (www.fungramkb.com) for the development of applications in the field of natural language processing and the semantic web.

He was director of the Consolidated Research Group, ACTUALing, since 2006-2011 and is currently the President of the Spanish Association of Applied Linguistics (AESLA: http://www.aesla.uji.es).

#### Mato de la Iglesia, Salustiano (España)

Rector of Universidad de Vigo. Doctor in Biology by the University of Santiago de Compostela in 1986, Salustiano Mato is Full Professor of Zoology in the Faculty of Biology of the Department of Ecology and Animal Biology of the University of Vigo, institution of which he was Vicerector of Investigation between May of 1998 and August of 2005.

He developed his research career in the field of biology and earthworm fauna in Galicia, participating in various projects for the inventory and cataloging of terrestrial invertebrates and publishing different papers in scientific journals of international prestige.

In 1987 he was a postdoctoral researcher at the American universities of Rutgers and Cornell, participating in the development of compostage systems being designed there. After his return to Galicia, he began a new line of research based on the design of composite systems in which the correct development of the biological process was preceded by only technological criteria. As a result of this work, several scientific and technical publications emerged, as well as two patents of invention. In the last years, between 2005 and 2009, he worked as General Director of R & D & I in the Xunta de Galicia.

# Mayor, Federico (Spain)

Born in 1934, Federico Mayor has a PhD in Pharmacy. Director of the Severo Ochoa Molecular Biology Centre (Madrid, 1973-1978). Under-secretary of the Spanish Ministry of Education and Science (1974-1976). A member of Parliament and Chairman of the Parliamentary Commission for Education and Science (1977-1978) he later became Adviser to the Prime Minister on these questions. Minister of Education and Science (1981-1982), in 1987 he was elected a Member of the European Parliament. After being Deputy Director-General of UNESCO from 1978 to 1981, he returned to the Organization as Special Adviser to the Director-General (1983-1984), whom he succeeded in 1987.

#### Morrison, Sandy (New-Zealand)

Sandy is the President of ICAE, International Council for Adult Education, a global NGO which advocates for the right of adults to education and lifelong learning. She also served as President of ASPBAE, Asia South Pacific Association for Basic and Adult Education from 2004-2008 and was inducted into the International Adult and Community Education Hall of Fame by the University of Oklahoma in 2009. As an Associate Professor at the University of Waikato, New Zealand, her research and professional specialty focuses on adult education, education for sustainability and the application of indigenous models in addressing social, environmental and developmental issues to improve livelihoods for indigenous peoples and peoples of the Pacific.

#### Muñoz, Leda M. (Costa Rica)

Leda Muñoz is the Executive Director of the Omar Dengo Foundation (FOD) and full professor at the Faculty of Medicine of the University of Costa Rica. During her professional career, she has concentrated in two main activities: as researcher, studying problems and evaluating solutions to improve the opportunities of development of children and youth in areas such as nutrition, education, health and poverty. Her second area of experience is the design and implementation of large scales sustainable programs in the above-mentioned areas. During the last seven years as FOD's Executive Director, she has been promoting educational interventions that support the development of skills and talents of the younger generations. The Omar Dengo Foundation's main program – the National Educational Informatics Program (PRONIE MEP-FOD) – is in charge of designing, implementing, monitoring and evaluating innovative educational models supported by digital technologies, with the purpose of promoting the development of 21 st century cognitive and social skills, from a social and educational equity perspective. The program's goal is to reach 100% of the country's primary and secondary education students by 2018.

Rector of open University of Netherlands and President of EADTU.

Prof. Mr. Anja Oskamp studied law in Rotterdam and spent a year at the Norwegian Research Center for Computers and Law in Oslo after her studies. There she conducted research on both the domain computer law as legal informatics. In 1983 she became a lecturer at the VU University in Amsterdam where she was a founding member of the Computer / Law Institute in 1984. Oskamp received her doctorate in 1990. In 2001 she became a professor Legal knowledge management and IT, and in 2005 Dean of the Faculty of Law of the VU University. She was also extraordinary professor of computer science, tax law and tax computer law at the Radboud University Nijmegen from 1997 to 2005.

Amongst other responsibilities, he has been Directors of the Centro de Altos Estudios Universitarios of the Organization of Ibero-American States for Education, Science and Culture (2008-2012), Secretary-General of Education at the Ministry of Education and Science (2004-2008), Vice-Recto of Evaluation and Innovation at UNED (1999-2003), Director of the Instituto Nacional de Calidad y Evaluación (1994-1996), Director of the Centro de Investigación y Documentación Educativa (1989-1994), Director of the Centro de Medios Audiovisuales of UNED (1989) and Rector of UNED. He has worked with UNESCO, OCDE, World Bank, OEI, Banco Interamericano de Desarrollo and ALECSO. He is author of 20 books and more then 200

articles on different topics related to the history of contemporary education systems, education policies and evaluation of educational systems.

# Titlestad, Gard (Denmark)

Secretary General of ICDE.

Gard Titlestad joined ICDE in August 2011 after six years at the Nordic Council of Ministers in Copenhagen, Denmark where he was Head of the Department for Knowledge and Welfare. He managed the secretariat for various configurations of ministers; the ministers for education and research, the ministers for health and social affairs, and before that also the ministers for labour affairs and ministers for IT. Gard's focus was on Nordic cooperation in education, research and innovation and the so called knowledge triangle, and in particular the role of universities. Under his guidance, major initiatives were taken within research and design including a top level research initiative targeted towards climate change and the sustainable economy, and within education the new Nordplus programme Nordic eScience, and development of cooperation on high capacity networks and supercomputing in the Baltic Sea area. Gard was also active in facilitating policy initiatives for new welfare models and in cooperation within health.

Before joining the Nordic Council of Ministers, Gard served as Research Counsellor for Norway in Brussels, Belgium, facilitating Norwegian participation in European cooperation, including on Information Society initiatives. He participated in the executive team of the Norwegian delegation to the European Union.

His experience from international cooperation on research and development and IT spans many areas from concrete cooperation within cancer research, major developments on the oceans, to broad Information Society initiatives.

# **Troussier, Thierry (France)**

Thierry Troussier is a Senior public health medical specialist and Sexologist. He holds a Degree in Sexology from the University Paris-Diderot, a Degree in Public Health from the Ecole des Hautes Etudes en Santé Publique in Rennes and a PhD in Medicine from the Grenoble University. He occupies the position of "Chargé de mission" at the Health Directorate General of the French Ministry of Health where he is coordinator of the national program for HIV-AIDS / STIs prevention and sexual health strategy for Metropolitan France and the five French Overseas Territories. He is the Head of the International UNESCO Chair and UNITWIN Network International on Sexual Health and Human Rights. Thierry Troussier is also professor and Head of the Sexual Health, Sexology and Human Rights Pole at the Paris-Diderot University. He contributes to the organization of public conferences on sexual health and human rights and coordinates research in France for WHO/RHR. He is an active member of the WHO where he occupies the position of Chairman of the WHO Guidelines Review Committee, member of the WHO Technical consultation on the techniques of sexuality related communications and Co-Coordinator for developing research protocol/s for multisite studies. Moreover, he has 30 years of professional experience in public health program management) and is Lecturer in Universities (Paris-Diderot, Brescia), NGO's and leadership in sexual Health, STIs and HIV at an international level.

#### Vaioleti, Timote M. (Tonga)

Dr Vaioleti is a Senior Research Fellow and is from Tonga. His academic work on Talanoa methodology and Manulua is considered groundbreaking. He led the development of the Kiribati Climate Change school curriculum and assisted the re-orientating of the Teacher Education Institutions in Africa to include Education for Sustainable Development (ESD). He also chairs an NGO called IMPAECT\* (Indigenous Māori and Pacific Adult Education Charitable Trust) which is engaged in several ESD projects particularly in the South Pacific. In 2011, he was inducted and is the only Pacific person admitted to the International Hall of Fame for Community and Adult Education based at the University of Oklahoma, USA.

#### Valdes Cotera, Raul (Mexico)

Raul's professional career focuses on developing and implementing adult learning, education and lifelong learning policies and strategies in UNESCO Member States at national, regional and global levels. In his work at the Regional Cooperation Centre for Adult Education in Latin America and the Caribbean (CREFAL) and the UNESCO Institute for Lifelong Learning (UIL), he has established thriving institutional partnerships with ministries of education, city governments, regional and international agencies, civil society organizations and the private sector. These strong partnerships have led to interventions on capacity-building, research coordination, policy recommendations and publications. Over the past two years he has overseen the rapid growth of the UNESCO Global Network of Learning Cities (GNLC). Despite the fact that the Network opened to membership a year ago, already more than 180 member cities from all five UNESCO regions have joined it. Together with his team, he has organized several major events, including the UNESCO Learning City Award, the development of a set of Guidelines for Building Learning Cities, and the publication of a collection of case studies on learning cities. At UIL, he has continuously expanded the lifelong learning knowledge base, and promoted the operationalization of lifelong learning through the UNESCO Observatory of Recognition, Validation and Accreditation (RVA) of the Outcomes of Non-formal and Informal Learning.

#### Villalba, Ernesto (Spain)

Ernesto Villalba is an expert at the European Centre for the Development of Vocational Education and Training (Cedefop) since 2011 working on European transparency tools and principles. He is main responsible in the area of validation of non-formal and informal learning, where he works together with the European Commission. During 2012 he worked in the development of the European Skills passport and in a prototype of a tool for recording non-formal and informal learning experiences within the Europeass framework. Before joining Cedefop he worked as a scientific officer at the Center for Research on Lifelong Learning (CRELL) at the Joint Research Center of the European Commission, Ispra, Italy. He is in the editorial board of the Journal of business creativity and the creative economy and the International Journal of Creativity and Human Development, and an editorial correspondent at the European Journal of Education.
